Demand for student mental health support surges during the COVID-19 pandemic - keep.meSAFE by guard.me helps Canadian schools provide continuity of care July 27, 2020

MARKHAM, ONTARIO – With demand for counselling and mental health services surging over the past several months, **guard.me** is helping Canadian colleges and universities support their students through their **keep.meSAFE** program, a cornerstone of the **guard.meCARES** mental and physical wellness platform.

Though most on-campus health services and clinics are closed due to the pandemic, **keep.meSAFE** provides students with access to mental health support and services whenever and wherever they need it. In addition to a range of self-help programs and mental health webinars available, linguistically and culturally-matched certified counsellors are available 24 hours a day, seven days a week, via text, email, phone, or video chat – providing access to care that is now more important than ever.

"Between school closures, border restrictions, financial pressures and the ongoing threat of COVID-19, many students are in limbo and experiencing additional stress right now," says Christina Furtado, Mental Health and Wellness Specialist at **guard.me.** The increase in **keep.meSAFE** app downloads and clinical sessions from January through April paints a clear picture of the added demand for student mental health support during the pandemic. "We saw a nearly 50% increase in downloads of our mental wellness support app from January to April," continues Ms. Furtado. "It's obvious that COVID-19 has added considerable stress above and beyond the strain study places on students. It's essential that our partner schools and organizations can provide continuity of care to their students around the globe during these unprecedented times. The **guard.meCARES** platform of programs, tools and services allows them to do just that.

Providing access to health and wellness programs and services, reaching well beyond the traditional notion of insurance, is nothing new for **guard.me**. "It's been our mandate for over 20 years," adds Keith Segal, Founder and CEO of **guard.me**. "And it's why we continue to evolve and grow our **guard.meCARES** resources. We want to be there for our students and educational partners even when insurance isn't needed. For us, it's about keeping students healthy, happy and learning as well as mitigation of potential crises.
